Physicians Head to Capitol Hill

enver Medical Society President-Elect Aaron Burrows, MD and Executive Director Kathy Lindquist-Kleissler joined a group of Colorado physician leaders in Washington D.C. in early March to participate in the AMA National Advocacy Conference and visit

members of the Colorado congressional delegation on Capitol Hill. The purpose of the meeting is to update physician leaders across the country on legislative and regulatory actions impacting the practice of medicine and to provide an opportunity for physicians to schedule face-to-face meetings with their members of Congress. Physician leaders from Colorado met with Senators Bennett and Udall and each of the Colorado members of the House.



This year the focus was on passage of legislation to permanently fix the SGR, the Sustainable Growth Rate formula which drives Medicare physician reimbursement rates. Colorado physicians were also asking for support for the Colorado Medical Clean Claims Task Force whose work over the past 31/2 years is producing a national model for transparency and uniformity in the medical claim edits process.

After years of frustration and delay, physicians once again faced an April 1 deadline for the repeal or temporary continuation of the SGR, but this year there had been some promising bi-partisanship shown in Congress with

the passage out of committees of reference of the SGR Repeal and Medicare Provider Payment Modernization Act of 2014, HR4015/S2000. before our arrival in Washington D.C., both the House and Senate committees passed this legislation, which would produce a new policy framework repealing the SGR and creating a pathway to a higher performing Medicare program, on a bi-partisan basis. Colorado physicians called on our

There seemed to be unanimous support for a permanent fix, but the sticking point has been where to find the money to cover the costs of the transition to a new Physicians across the country methodology. have urged members of Congress to act now to identify funding sources when there is bi-

partisan agreement on a path forward and the Congressional Budget Office has estimated the cost of a permanent fix to be at its lowest point in recent years.

After our return from D.C. it was announced that the House leadership was putting forth a proposal to fund the SGR fix by delaying for 5 years the implementation of the individual mandate under the ACA. This proposal was voted on in the House in mid-March and passed along a party line vote. It was obvious that this approach had no prospect of passing in the Senate. On March 31 the Senate passed HR4302, already passed by the House, which postpones the scheduled 24% cuts until April 1, 2015—the 17th temporary patch. The bill also delays scheduled ICD-10 implementation until October 1, 2015. DMS will continue to advocate for a permanent solution to the Medicare payment system.

The second issue Colorado physicians addressed with our members of Congress was a request already made to the Centers for Medicare and Medicaid Services to designate the work of the Colorado Medical Clean Claims Transparency and Uniformity Task Force be granted pilot project status and provide it funding under provisions of the ACA Administrative Simplification requirements. The Task Force was created by the Colorado Legislature in 2010 to bring together a broad based set of stakeholders to develop a uniform set of claim edits that could ultimately be adopted by all payers in Colorado. For over three years, a group of national and local representatives and experts have worked to achieve consensus on a uniform edit library and to explore implementation strategies. It has been estimated that a uniform set of medical claims edits and payment rules could yield a savings of \$80M to \$100M per year in Colorado alone. The Task Force is asking CMS to designate their work a "national pilot" and supply funds over the next two fiscal years to support the testing and implementation costs of this effort.


